

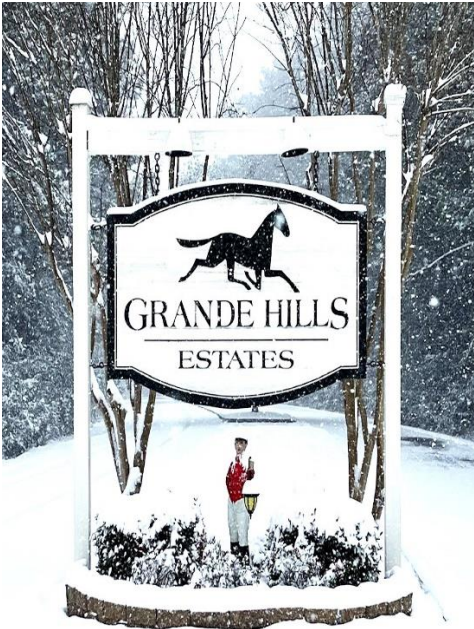

2025 ANNUAL MEMBERSHIP MEETING AND ELECTION RESULTS

Thank you to all the members who participated in this year's election by sending in your ballots and attending the annual meeting.

BOARD OF MANAGERS

The election for the 2025 Board of Managers for the GHEHA was held on February 1, 2025. The meeting was originally scheduled for Saturday, January 25, 2025. Due to the inclement weather from the snow fall, icy roads and numerous road closures the Board agreed to reschedule the meeting out of concern for the safety of our members.

The 2025 proposed annual budget in the amount of \$18,470.00 was **APPROVED** by 97.17%. Therefore, each member's annual assessment for 2025 is **\$14.72 per acre owned.**

Please ensure your payment is **RECEIVED** by the Association

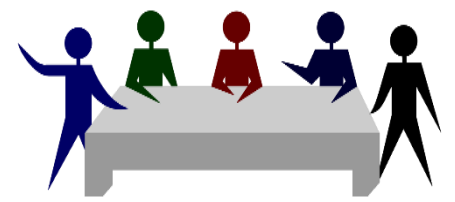
BEFORE MAY 1, 2025, to avoid assessment of a late fee.

The Association appreciates your prompt remittance as there are expenses that are currently due. Thank you for your continued support of your Association.



The board passed a resolution in JANUARY 2023 to INCREASE the late assessment fee from \$25.00 to \$100.00 for assessments paid late or not in full. This late fee is necessary due to continued delinquent payments year after year of some members. Any payment not received in full on or before April 30th will be late and will be returned to you along with additional fees as applicable of the late fee, and all other related costs. If not paid within 7 days of the revised assessment fees, the Board is then required to file a claim to the Justice of the Peace for Small Claims Court in St. Tammany Parish. If not paid at this point, a lien will be placed on your property. Please pay your assessments in full on or before **April 30th.**

LAKE COMMITTEE

The lake committee requests that if you catch a fish that is under nourished which has a big head and small body, please keep the fish, but should you catch a large bass over five pounds please return back to the lake. The committee would like to have feedback from the members to help evaluate the progress thus far as to the fishing and population in our lake. two per day. Note: any bass less than 14" in length that appears undernourished (big head and small body) can be kept and taken out of the lake. Although bass in the 14-17" slot limit are acceptable to keep, recommended during spawning seasons fish of this size should be returned to the lake if they are healthy.

Note: Bass spawns in the spring when waters warm up to the 60-degree range.

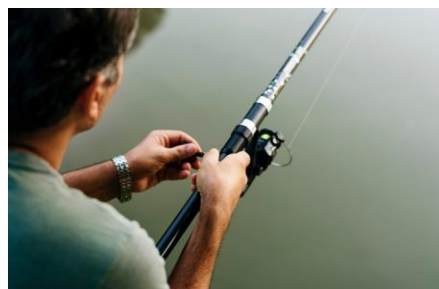
It is suggested by the lake committee that if any landowner who lives on the lake wants to dredge the shoreline of their property to contact either a committee member or the Board prior to the project. Considering the issues of improving fish habitat and restocking our lake, dredging the shoreline may need to take place at certain times of the year.

SUMMARY OF THE 2025 ANNUAL MEMBERSHIP MEETING



Our annual election/membership meeting was highly informative. Thank you for attending and showing your support for your community.

Our guest speaker, Ms. Cheryl Tanner, Councilwoman for our district, was present. She advised the members regarding Highway 3241, in Bush, which will connect to I-12 at the Lacombe exit, that she is working with the Parish to ensure proper zoning is in place once the highway is complete, so to hopefully avoid future zoning issues. Highway 3241 will be a four-lane highway constructed in three phases. Phase three has been completed and phase two is presently under construction. There are different contractors for each phase.

KEYS FOR BOAT LANDING



Please note that the boat launch keys are assigned to you by number and should be used only by property owners in this subdivision. A **\$25.00** refundable deposit is required to obtain a key. If you would like a key to the boat landing, please call our Board Member, Susan Chartier: (985) 809-1455. Please remember this is a voluntary position, so please allow sufficient lead time to obtain a key and timely consideration when calling.

Should you move out of Grande Hills you will be required to turn in your key to receive your deposit. A sign-in list will be kept for members holding keys.



PRIVATE PROPERTY

Every lot in Grande Hills Estates is owned by someone. If you decide to go on land you do not own, without permission, you are trespassing. The Sheriff's Office can be called on this violation and a report can be filed.

Please note that four wheelers are not street legal.

Parking or riding a vehicle on the dam located on Churchill Downs Drive is not allowed as indicated by the 'No Parking Signs.' St. Tammany Parish Engineering Department advises that by parking cars, trucks, four wheelers or any other type of motorized vehicle on the dam area by the lake will weaken the dam.

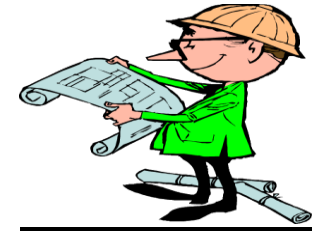


GHEHA WEBSITE

For easy access to the Covenants for Grande Hills, a link below the picture of the "horse" has been added to our website on the home page titled **Covenants and Deed Restrictions**. The Deed Restrictions were never changed due to the restrictive method for changing this document. Please refer to the GHACC Rules and Regulations as this document has been updated.

A link has also been added to pull up the Application for a **Certificate to Proceed**.



GHEHA ARCHITECTURAL CONTROL COMMITTEE

Our Architectural Control Committee (GHACC) is here to assist you in the smooth completion of your project.

As stated in the Grande Hills Architectural Control Committee Rules and Regulations a completed and approved Certificate to Proceed (CTP) is necessary for any new construction.

Before ANY construction begins, ALL plans for building structures, additions, fences, pools, etc. are to be submitted to the GHEHA for review.

The Architectural Control Committee Rules and Regulations states under Section 1.1.2. The GHACC shall have fifteen (15) days after receipt of all required documents to approve or disapprove any application for construction for any structure.

Please allow enough time for this process to be completed before commencement of any type of construction.

The Certificate to Proceed form is located on our website.

If your project is a structure that is greater than 100 square feet, a building permit from St. Tammany Parish is required.
